

INVITATION TO BID

CITY OF EDMONDS

Sealed bids will be received at the office of the City Clerk at 121 Fifth Avenue North, Edmonds, Washington, until 2:00 PM, April 23, 2024, for the construction of the 2024 Utility Replacement Project and the furnishing of all labor, materials and equipment necessary for this project. The project covered by these specifications and bid documents involves eleven schedules (A, B, C, D, E, F, G, H, I, J, and K) in the construction of the City of Edmonds 2024 Utility Replacement Project. The project consists of ±20 LF of 4-inch restrained joint ductile iron pipe with associated fittings and other appurtenances; ±40 LF of 6-inch restrained joint ductile iron pipe with associated fittings and other appurtenances; ±3,385 LF of 8-inch restrained joint ductile iron pipe with associated fittings and other appurtenances; ±430 LF of 12-inch restrained joint ductile iron pipe with associated fittings and other appurtenances; 6 fire hydrants; 11 connections to existing water main; water service replacements; temporary main and services; ±150 linear feet of 6-inch diameter PVC side sewer; ±770 linear feet of 8-inch diameter PVC sewer main; ±6,665 linear feet of 8-inch diameter CIPP sewer main; ±260 linear feet of 10-inch diameter CIPP sewer main, installation of 6 new manholes; connection to 9 existing sanitary sewer system; replacement of sewer service connections; ±35 LF of 6-inch storm drainage pipe; ±90 LF of 8-inch storm drainage pipe; ±155 LF of 12-inch storm drainage pipe; ±150 linear feet of 6-inch diameter CIPP storm drainage pipe; ±370 linear feet of 8-inch diameter CIPP storm drainage pipe; ±250 linear feet of 10-inch diameter CIPP storm drainage pipe; ±5,550 linear feet of 12-inch diameter CIPP storm drainage pipe; 2 drainage structure; ±655 tons of HMA CL ½” PG 58H-22 for permanent trench patching; ±4,305 tons of CSBC for trench backfill, bedding, and road base; replacement of pavement markings, and concrete curb and gutter and sidewalk.

A certified check, cashier's check or bid bond in the amount equal to at least five percent of the total amount of bid, including sales tax if applicable, must accompany each bid as evidence of good faith and as a guarantee that, if awarded the contract, the bidder will execute the contract and give a performance and payment bond as required. The check will be given as a guarantee that the bidder shall execute the contract in conformity with the contract documents if it is awarded to him and shall provide a performance and payment bond as specified therein within ten calendar days after notification of the award of contract to the bidder.

The City of Edmonds reserves the right to reject any or all bids, and to waive irregularities or informalities in the bid or in the bidding. No bidder may withdraw their bid after the hour set for the opening thereof or before award of contract, unless said award is delayed for a period exceeding sixty calendar days.

The City of Edmonds, in accordance with the provisions of Title VI of the Civil Rights Act of 1964 (78 Stat. 252,42 U.S.C. 2000d to 2000d-4) and the Regulations, hereby notifies all bidders that it will affirmatively ensure that in any contract entered into pursuant to this advertisement, disadvantaged business enterprises will be afforded full and fair opportunity to submit bids in response to this invitation and will not be discriminated against on the grounds of race, color, or national origin in consideration for an award.
